

Alpha & Omega Dance Academy Fayetteville Summer Session Rates & Policies

As a special thank you for dancing with us this summer, there is NO registration fee for summer dance, whether you are a current member or brand new. Plus, students enrolled over the summer will also be eligible for a discount on our Annual Registration in the fall! (Please see our Fall Rates & Policies for more details). This is our way of showing how much we appreciate you!

Summer Rates & Discounts for Dance Classes

Summer classes run weekly for our 6-week session, so the price below denotes the price for taking 1 (or more) class for the entire session. Tuition is a one-time payment due at time of registration (which covers all 6 weeks of the Summer Session).

1 Student at 1 Class:	\$84 for the 6-week session
1 Student at 2 Classes:	\$114 for the 6-week session (second class is only \$30!)
1 Student at 3+ Classes:	Each additional class is only \$22.50 more for the 6-week session!
Family Discounts for Classes:	The second family member receives a <i>10% discount</i> , and additional family members receive a <i>50% discount!</i> Please note that discounts for classes do not carry over to Summer Programs, and vice versa. Contact the office with any further questions.
Please Note:	Our Summer classes are priced at the same rate as our Fall/Spring 2023-2024 classes and have a one-time payment that is pro-rated for that 6-week Summer Session versus making a monthly payment.

Summer Rates & Discounts for Dance Camps & Intensives

All tuition for camps or intensives is due Monday, June 24th, regardless of their start date.

Camps for Ages 3-6:	\$150
Choreography/Improvisation Intensive Ages 11+:	\$200
Family Discounts for Camps/Intensives:	The second camp/intensive for the same student receives a 10% discount (this 10% discount applies to any additional camps/intensives, as well). Additional family members who pay for a camp/intensive, also receive a 10% discount (even if they are not signed up for the same program). Only one of these discounts can apply to an individual program.

Payment/Billing Method Policy: Everyone is required to set up an automatic payment method through the AODA Portal. Please familiarize yourself with our Tuition Policy. AODA accepts Visa, Mastercard, and Discover. ****We currently do not accept AMEX, cash, check, or money order****

(Please remember that those who sign up mid-session will receive prorated tuition for dance classes, but our camps and intensives do not have this option).

Summer Missed Classes Policy: Missed classes are not refundable but can be made-up in a similar level/age-appropriate class during the Summer Session (they do not transfer to the next session). Due to max capacity, make-up classes must be scheduled in advance through the front office, so please contact the office to coordinate a make-up class. Missed days of a Summer camp or intensive are not refundable and cannot be made up; however, if you miss a weekly class to attend a camp/intensive, that class may be made up.

Mid-Session Registration Policy: Please note that while those who sign up mid-session will receive prorated tuition for dance classes, our camps and intensives do not have this option.

Summer Cancellation Policy: If you need to cancel your enrollment you must contact our office 2 weeks prior to the summer class/program's start date to receive a full refund (minus convenience fee). This notice must come from the parent (or student, if age 18+). Within 2 weeks of the start date, your cancellation notice must be sent 24 hours prior to the start date/time to receive a 50% refund. Any cancellation given within the 24-hours, or after that point, will not be refunded, but you will be given a 50% credit to your account for future enrollment if you contact us within 24 hours of the start date/time. Finally, there will be no 50% credit if canceling mid-program or mid-session. Please note that if we have not received payment after signing up OR a notice of cancellation at the office after signing up, we will still draft your card for any remaining balance due to everyone being required to be on automatic payment. *Due to the limited number of students we can accept in our Summer Session, this policy remains intact regardless of the reason for the cancellation. Thank you for understanding.

Outstanding Balance Policy: All payments must be up to date (with a \$0 balance) in order to withdraw from classes and enroll in future classes.

Costume Fee/Recital Policy: There is no recital or costume fee(s) for Summer Session.

Inclement Weather Policy: For any inclement weather closure, there will be no refunds, but students are allowed to do a make-up class within the Summer Session period due to an inclement weather closure.

Sick Policy: I hereby agree to AODA's Sick Policy, outlined under the Fayetteville tab under "Rates & Info" on AODA's website.

Statement of Faith Policy: We are a Christian dance studio, and therefore, the decisions and protocols we make regarding our recital themes, who we hire, dress code, costumes, events, etc. are made from that perspective. We understand that every family has their unique values and may or may not agree with us, however, by enrolling at our studio, you are agreeing to respect our decisions and protocols.
